# PRE-FLIGHT ADMINISTRATION

Drone Property Inspections will be carried our subject to:

- A. Confirmation of engagement in the form of a Purchase Order signed by an authorised signatory or written acceptance of our quotation
- B. Written land owner's permission of the site location
- C. Written permission from the local airport if site location is within an airport's Flight Restriction Zone. Any charge imposed in obtaining such permission will be passed on at cost.
- D. Written permission from any other authority e.g. Port of London Authority etc. Any charge imposed in obtaining such permission will be passed on at cost.

The rates below are inclusive of return travel up to 30 miles from our base location in London, SW14. Additional return mileage will be charged at 45p per mile.

# **PAYMENT TERMS**

EDS will forward an invoice for the quotation value to the client on receipt of written acceptance of the quotation from the client.

50% of the invoice value then becomes immediately. Upon confirmed receipt of funds, EDS shall conduct the flight mission on the agreed date, subject to suitable weather and the receipt of the necessary permissions. The remaining 50% of the invoice value is payable immediately upon EDS electronically delivering the imagery to the client.

The Client shall pay EDS, the sum and other amounts as outlined and agreed in the quotation. Any additional work requested that has not been previously agreed upon or that has not been included in the initial quotation, will be charged for on a 'time and hire' basis calculated on the basis of EDS's standard rates (standard rate for half day/short task at £250 + any other reasonable expenses).

EDS reserves the right to amend any quotation prior to both parties agreeing or based on any new information which comes to light from either a site survey or prevailing weather conditions or consent of any location owners, or requirements for additional equipment and/or time and/or Operatives to ensure the safe and professional operation of the Services.

If, at any time after the client's acceptance of the quotation, the client no longer wishes to receive our services (or any part of the services) we reserve the right to charge the client a cancellation fee not exceeding the total invoice amount.
